to a greater extent than other council tax payers, ratepayers or inhabitants of the authority's area".

11.	any land in the authority's areas in which you have a licence (alone or jointly with others) to occupy for a month or longer; and	
12.	any visit outside the UK for which the authority has paid or will pay;
